Additional details for OE exhibitors

Move in and move out

Move-in day is Wednesday, February 7th, 2024. Move-out is Friday, February 9th, 2024.

By 8:00 p.m. on Friday, February 9th, 2024, all vehicles must be completely removed from the International Centre.

Once your participation is confirmed, the CCIF events team will provide you with the full logistics.

Rules and regulations

Manufacturers participating in the CCIF 2024 trade show must carry General Liability and Workman's Compensation Insurance and provide CCIF Events with the appropriate certificate of insurance by December 15th, 2023.

Vehicles or other flammable fueled engines displayed must adhere to the following requirements:

- Motor vehicles or gasoline-powered equipment on display must be equipped with lock-on type gasoline tank caps and batteries are to be disconnected.
- Gasoline tanks must not be filled beyond the $\frac{3}{4}$ mark. This is to allow for expansion of product.
- Vehicles that are unable to be equipped with lock-on type caps must have caps sealed in a manner acceptable to the Fire Department.
- •The electrical system must be de-energized by one of the following methods:
 - Removing the battery.
 - Disconnecting both battery cables and covering them with electrical tape or other similar insulating material.
 - Running of display vehicles during exhibit is prohibited unless approved by the Fire Department.
- Vehicles must be filled outdoors from approved safety containers.
- All vehicles must either have sealed undercarriages or are to be equipped with ground sheets.
