Nominee biographies

Élisabeth Lambert | Owner | Pièces d'Auto Joliette



Élisabeth Lambert is the owner of Pièces d'Auto Joliette, a parts store that is part of the Bumper to Bumper network. Although the aftermarket industry has been part of her life since childhood, she officially joined it in 2010. Starting as an accounting clerk, she quickly discovered a passion for the industry and worked diligently to rise through the ranks. She progressed from accounting clerk to controller, then general manager, and became co-owner in 2016. In January 2024, she fulfilled her dream of becoming the sole owner of the business.

Driven by a passion for the challenges and issues facing the industry, Elisabeth has been actively involved with AIA Canada's Quebec Division since 2018. She participates in youth



engagement activities and contributes to events such as the Grand Forum and the division's golf tournaments. Elisabeth also played a key role in the advancement of Bill 29 in Quebec, which focuses on product repairability, even speaking at a parliamentary commission alongside Jean-François Champagne.

Élisabeth served as President of AIA Canada's Quebec Division from April 2022 to December 2024, becoming the first woman in the division's history to hold this position.

She is also engaged in her community. Since 2022, she has been a board member of Moisson Lanaudière, a regional food bank dedicated to fighting food insecurity—a cause close to her heart.
